Little Saints tuition rates are figured monthly and are based on the child's age group. The monthly tuition rate does NOT include the ONE-TIME application fee (\$400) and NEW Enrollment Fee(\$150) for new students; and an Annual Re-enrollment Fee (\$150) for returning students. Financial Assistance

Step Up for Students: Step Up For Students is a nonprofit organization that administers the Florida Private School Scholarships such as the Florida Tax Credit Scholarship (FTC), Hope Scholarship, and the Family Empowerment Scholarship-Educational Options (FES-EO). They also administer the Family Empowerment Scholarship for Students with Unique Abilities (FES-UA) formerly known as the Gardiner and McKay Scholarships. Apply at www.stepupforstudents.org.



Multi-Child Discount: This discount is for related children, enrolled in PreK - 8th grade at the same time, who are being paid for by one party. It allows a 5% reduction in the second child's tuition; 10% in the third child's tuition; and 15% in tuition for the fourth child. For this calculation, Florida Private School Scholarships are deducted first from the tuition.

Full Payment Discount: Many families take advantage of our "Full Payment Discount" by which one can take 5% off the balance owed at contract signing. This full payment plan must be paid no later than **May 1, 2026**. For this calculation, Florida Private School Scholarships are deducted first from the tuition.

FACTS Grant and Aid: There are many factors that influence financial aid decisions, including the availability of school resources, the number of qualified applicants, and overall budgetary constraints. Families seeking direct financial assistance from Saint Michael must first apply for the Step Up For Students Scholarship and comply with the requirements indicated by the FACTS Grant & Aid system online at www.factstuitionaid.com.



FACTS Online Payments: All families are required to sign a tuition agreement and set up a FACTS monthly payment plan when they enroll their child(ren). There is an annual fee of \$55 per family for the maintenance of this monthly plan which also covers the use of FACTS for incidental expenses. Incidental expenses include, but are not limited to, fees and charges for Extended Care, athletics, lunch, graduation, and school supplies that are required to be purchased from the school, field trips, clubs, library, and class shirts.
